

Areas for Cleaning:

Diverse

- Level 1 Standard daily cleaning with usual and maybe enhanced in high touch areas (cleaning > 1X per day and more)
- Level 2 Suspect case on premise step up clean and frequency relative to traffic and shared areas (hourly pending population present)
- Level 3 Confirmed case and they should follow contact precautions, clean with proper covering and PPE, Extra thorough. Some companies are waiting 24 hours to allow air to circulate, pending type of business / facility and airflow. As most facilities have a strong air exchange, we recommend at least 10 minutes.





Employee Reminders:

Office Environments Higher Level Cleaning

Cleaning and Disinfection After Persons Suspected/Confirmed to Have COVID-19 Have Been in the Facility

In an office, or other facility that <u>does not house people overnight</u>:

- It is recommended to close off areas used by the ill persons and wait as long as practical before beginning cleaning and disinfection to minimize potential for exposure to respiratory droplets.
- Open outside doors and windows to increase air circulation in the area or increase air exchanges.
- Ensure PPE is in place and confirm supplies are in stock for disinfectants, disposable cleaning cloth(s), and equipment.
- If possible, **wait up to 24 hours** before beginning cleaning and disinfection.
- Cleaning staff should clean and disinfect all areas (e.g., offices, bathrooms, and common areas) used by the ill persons, focusing especially on frequently touched surfaces and all areas. Consider floor disinfection as appropriate for the facility.
